Job Description

The RCAHT (Riverside County Anti-Human Trafficking) Response Team Advocate assists with the Task Force's initiatives for the identification and support of victims or survivors of all forms of human trafficking. The Advocate provides trauma-informed, culturally, and linguistically appropriate mobile and field-based advocacy by accompanying law enforcement on proactive operations and at RCAHT community-based outreach activities. The Advocate assesses the needs of the victims, provides crisis counseling, information, safety planning, and conducts warm hand-offs to appropriate referrals ensuring that victims have access to a comprehensive array of victim-centered support services based on individual needs to mitigate the impact of victimization. The Advocate provides in-person emergency response to victims, when requested by law enforcement and medical providers. Additionally, the Advocate participates in case consultation with law enforcement and medical providers. The Advocate will be stationed with the Riverside County Sheriff's Department Human Trafficking investigators half-time, and at Rebirth Homes' office in Riverside half-time.

Job duties include, but are not limited to:

Advocacy

- Assess individual client cases to identify human trafficking and refer clients who have not been trafficked appropriately
- Accompany law enforcement on operations
- Accompany clients to law enforcement interviews and various appointments related to case as requested
- Maintain a working relationship between Barbara Sinatra Children's Center, REACH and Rebirth homes for referrals and resources for clients. Meet monthly with representatives from each agency to maintain proper communication and

ensure victim service provider's task force goals are being met. Identify and address any challenges with goals or service provisions.

- Attend all RCAHT Task Force Meetings as a representative of agency
- Conduct Needs Assessment for client to ensure physical and mental needs are being addressed
- Provide case management services as needed, and refer clients to local agencies for long-term case management needs (can refer to Rebirth Homes or REACH for long-term case management)

Outreach

- Connect with and develop professional relationships with local service providers who may come into contact with victims of human trafficking, including but not limited to local rehab treatment facilities, hospitals, etc.
- Attend community trainings provided by RCAHT Outreach Worker and Community Service Officer and offer advocacy services to anyone who may identify as being trafficked
- Attend outreach activist with Outreach Worker and Community Service Officer
- Refer clients interested in Rebirth's Victim to Survivor Program to Program Manager or other staff within 1 business day

Other duties as assigned

This role provides leadership to volunteers who serve in the areas outlined in the job description

Qualifications/Experience

The ideal candidate will have the following experience/skills:

- Strong ability to listen and validate
- Able to resolve conflict well
- Previous volunteer experience with Rebirth Homes or another anti-human trafficking organization is a plus.
- Bachelor's degree required; Master's preferred

Requirements

- Valid CA Driver's License
- Proof of insurance/clean DMV record

Physical Requirements

This role requires lifting and moving of up to 50 lbs. The work environment has household noises such as TV, music and other noises.
